

## **Elim Christian Centre Tokoroa – The Cult of Narcissistic Sociopaths III.**

17<sup>th</sup> of June 2018

The third Epistle of Richard Sivell, an unworthy servant of the Truth, to the Church of New Zealand. *“I know that after I leave, savage wolves will come in among you and will not spare the flock. Even from your own number men will arise and distort the truth in order to draw away disciples after them. So be on your guard.”*<sup>1</sup> – Apostle Paul.



*“For such men are false apostles, deceitful workmen, masquerading as apostles of Christ. And no wonder, for Satan himself masquerades as an angel of light. It is not surprising, then, if his servants masquerade as servants of righteousness. Their end will be what their actions deserve.”*<sup>2</sup> – Apostle Paul.

Gordon managed to track down the mortgage broker and we both had a face to face meeting with her and her husband on the 10<sup>th</sup> of June 2018. She verified that Brian Hagger, in fact, did demand that \$15,000 was to be added on to Barbara’s mortgage for his personal gain.

So...here we are, the third epistle regarding pulpit pimp Hagger. Just as the Apostle John in his third epistle needed to address Diotrephes for doing the same thing, wanting pre-eminence, bullying people in to submission and casting brothers out of the church.<sup>3</sup>

The mortgage broker and her husband have their own ministry, doing the work of the Lord, so Gordon and I discussed this and came to the conclusion, it is not in the best interest of their ministry to be publicly dragged in to this fight. This is not their battle, they are both ministers of the Holy Spirit, so Gordon and I made statutory declarations without naming them. See the appendix. We do have emails from them after our meeting, but it is Elim New Zealand's responsibility to rectify this matter.

After Barbara gave Brian \$3,000 for supporting her in to the home and Barbara personally covering all payments, Brian, greedy for filthy lucre<sup>4</sup>, then demanded an additional \$10,000 if the house was to be sold or refinanced. Once the meeting with the mortgage broker was organised, Brian then requested \$15,000 was to be added on to her arrangement for his financial benefit.

When Barbara was questioned by Trevor, it was stated that Brian said the \$15,000 was for Barbara to do renovations, to which she responded, "We did not have that conversation!" The mortgage broker has confirmed, the \$15,000 was for Brian, vindicating Barbara. Brian accused Barbara of being a liar and implied 'witchcraft' was used to manipulate Gordon in to assisting her with her plight. When in fact, it is Brian that has been proven the liar. Brian then falsely accused Gordon of being a 'robber' and deflected attention away from his own attempt to rob \$15,000 from an elderly woman in the church. The narcissists' greatest enemy are those who are genuinely righteous, in this case Gordon and Barbara, because instinctively Brian understands that genuine righteousness is a threat to his own masquerade.

## These are serious issues:

- Brian based his ministry on a lie and continues to lie.  
*“If we claim to have fellowship with God yet walk in the darkness, we lie and do not live by the truth.”<sup>5</sup> – Apostle John*
- Brian used his position in the church to try and extort \$15,000 out of an elderly woman in the congregation.  
*“Be shepherds of God’s flock that is among you, serving as overseers – not because you must, but because you are willing, as God wants you to be; not greedy for money, but eager to serve.”<sup>6</sup> – Apostle Peter*
- Bearing false witness against members of the congregation.  
*“Don’t extort money and don’t falsely accuse people.”<sup>7</sup> – John the Baptist*
- Spiritually abusing members of the congregation.  
*This is what the LORD says to the shepherds who tend my people: “Because you have scattered my flock and driven them away and have not bestowed care on them, I will bestow punishment on you for the evil you have done.”<sup>8</sup> – Prophet Jeremiah*
- Practicing favouritism and nepotism.  
*“If you show favouritism, you sin and are convicted of the law as lawbreakers.”<sup>9</sup>  
- Apostle James*
- Distributing Jewish propaganda through a Christian church.  
*“Watch out for those dogs, those evil men, the mutilators of the flesh. For it is we who are the circumcision, we who worship by the Spirit of God, who glory in Christ Jesus, and put no confidence in the flesh.”<sup>10</sup> – Apostle Paul*

## Conclusion

Trevor can no longer say, “That is your opinion.” It has been proven, the mortgage broker has corroborated Barbara’s testimony. Trevor stated, “he couldn’t go on our opinions” but if it was proven, then yes, Brian is in the wrong place. Will you have the courage to follow through and do the right thing? It is our clear conviction that Brian Hagger needs to be immediately removed from the position of pastor. *What fellowship can light have with darkness? What does righteousness and wickedness have in common?*<sup>11</sup>

I also believe it is appropriate for Barbara Taylor and Gordon Wilson to receive a clear acknowledgement and apology from Luke Brough on behalf of Elim New Zealand for how they were treated by Brian Hagger. He used the Elim church as a covering, he demanded secrecy, tried to rip Barbara off and then attacked her. Called her a “liar” and disclosed confidential information. He then turned on Gordon, falsely accused him of being a “robber” and bullied both of them out of the church. Brian Hagger’s behaviour is not beyond reproach, he is not fit to hold that position, and this type of conduct allows the world and the ungodly to pass judgement on the church.

The national leadership team has let down Tokoroa for placing Brian in that position. The reservations expressed at that time, inside the Elim executive, should not have been ignored.

Statutory Declaration (facsimile only)

I, Barbara Anne Taylor 48 Manaia St Tokoroa Teacher Require identification as to my identity and I hereby declare that my name is that which is shown above. I was born on the 21st September 1940 at Taumaranui. In 2005 Brian Hagger suggested that he finance me into the above house until I became eligible for a loan. The price for the house was \$71,000. I was to pay all fees which might arise from the setting up of his loan, and subsequently, all insurances, rates, maintenance and repairs without reference to the Hagers for recompense.

As soon as possible the loan was to be transferred into my name. These conditions were complied with. In early 2007 I became concerned that if anything were to happen to the Hagers there was no legal proof that we had the forgoing arrangement. I then requested that we put it all in writing. After some intermittent comments over subsequent months that, "I didn't have to worry about anything happening to them ", and, "I didn't do this for your family to gain," nothing was done, apart from a comment that if I sold he would require \$10,000. In November Brian introduced me to a mortgage broker and sat in on our initial meeting. As we were discussing the amount of the loan required Brian requested that we add \$15,000 onto the current amount remaining on his mortgage as he thought that was "a fair amount for supporting me for two years."


